- ▣ **Carried out by a consortium of 15 partners from 11 countries**

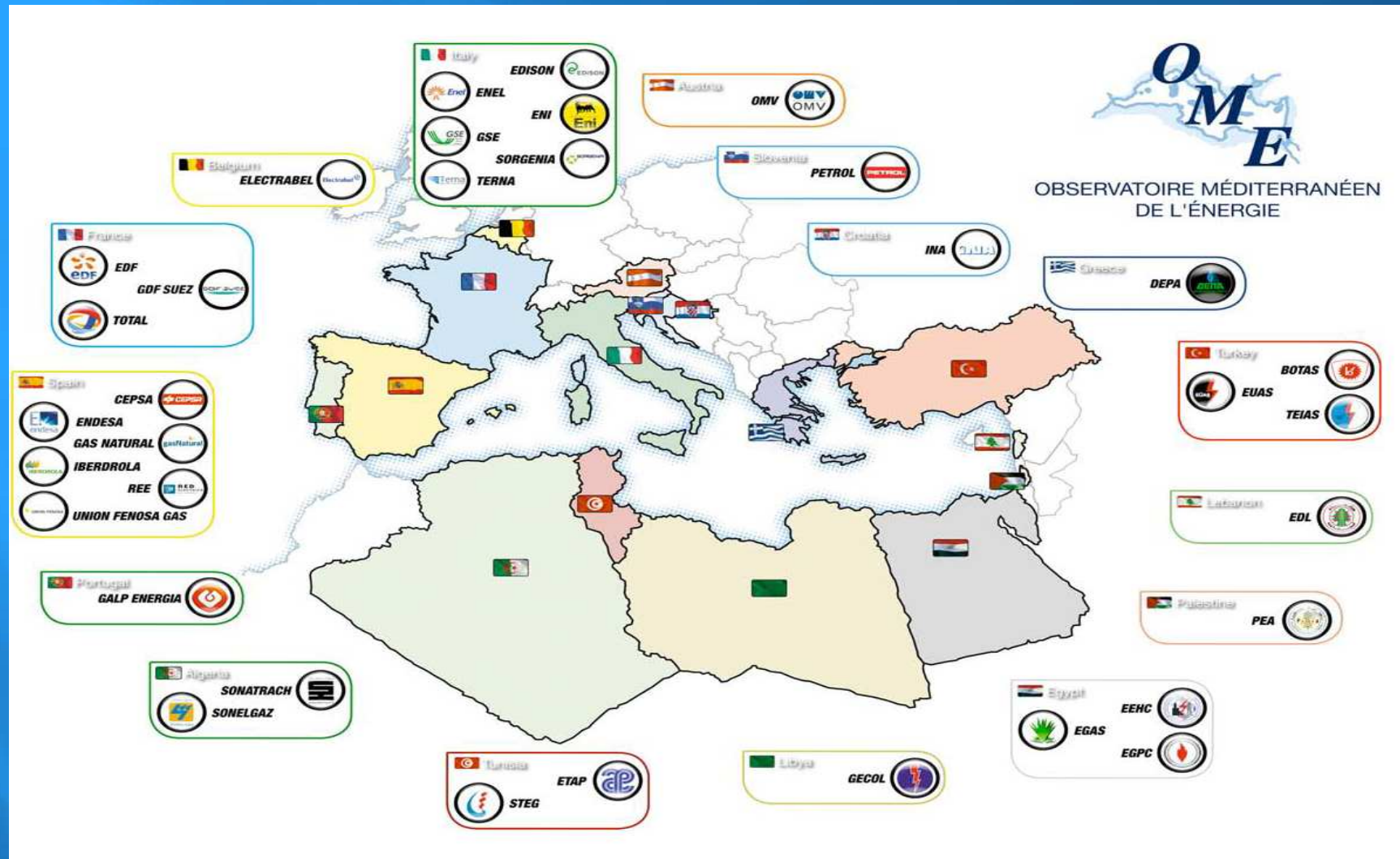
